# Drug-related research and EU policy on drugs

- Drugs policy in the EU A balanced, evidence-based approach
- Priorities established in EU drugs strategy (2013-2020)
  - 'Actions must be evidence-based, scientifically sound and cost-effective, and aim for realistic and measurable results that can be evaluated'
- and action plans (2013-2016):
  - Prevent drug use and delay the onset of drug use (objective 1, includes 4 specific actions)
  - Evaluation of policies and interventions (action 47)
- The Council's Annual Dialogue on Research where research priorities for funding can be discussed

## Disseminating and supporting research


#### The EMCDDA:

- Monitors research/studies used for Reitox reports
- Follows-up on and collaborates with EC funding programmes and with EC funded studies/research
- Contributes to the Council's Annual Dialogue on Research (Scientific Committee)
- Keeps a web area on research (national and EU level updates)
- Supports Member States, Reitox Focal Points and research organisations

#### Distribution of projects (11)




11 drug-related research projects funded since 2007 by programme. For most of these projects illicit drugs is not the main area of research.



- Min: €120,00 (DPIP), Max: €2 146 974,48 (ISEC);
- All focus on drugs/addiction



 The European Cooperation in Science and Technology (COST) calls – fund network efforts. Promotes international cooperation. Calls always open, with deadlines on March and September. Highly competitive.

# What will happen from 2014 on?

- Horizon 2020 (2014-2020) replacing FP7
  - Paperless
  - International collaboration
  - Open access outputs repository OpenAir (http://www.openaire.eu/)
- But... no specific topic for addiction:
  - Societal challenges:
    - Health;
    - Demographic change and wellbeing;
    - Inclusive, innovative and secure societies
  - Excellence in Science (Marie-Curie, ITN schemes, European Research Council)
- First Horizon 2020 calls to be published 11 December 2013
- DG funding programmes no clear overall picture
- COST scheme will continue

# **Current challenges**

Research projects, societies, collaborative academic centres, scientific paper awards and academic summers schools are contributing to 'promote, coordinate and improve more addiction research in Europe and to make its usefulness clearer to policy, public health and the general public' (Bühringer, 2012)

But still a big gap to fill in terms of science translation, advocacy and coordination...

More active and coordinated engagement/follow-up on Horizon 2020 and other funding programmes is needed
