



Prevention Hub Launch Report

On 26th June 2013 we launched phase one of the Prevention Hub website. We sent an embargoed press release to personal contacts within relevant organisations with newsletters such NIDA, CCSA, ECAD, MENAHRA and Mentor affiliates. We also asked relevant organisations to forward the information on to their networks.

In addition to the activities undertaken by Mentor International (newsletters, social media and sending to contacts), this report highlights the outcomes and external outputs of the Hub launch.

Hub Traffic:

Within the first five days, we had more than 800 unique visitors to the site - nearly 5,000 page views from 71 countries.

More than 250 members joined the Hub by the end of the first five days. We now have more than 1,400 organisations in the Hub.

- There is a wealth of drug prevention activity being undertaken around the world
- Mentor has a unique place amongst this activity as one of the only international non-government organisations with a focus upon coordinating and communicating with the prevention community from parent to researcher and everyone in between
- We have seen the gap between some practice and evidence
- How the commitment, effort and enthusiasm from prevention providers needs to be backed up with sound evidence of promise or effectiveness
- Avoid a duplication of effort and funds which can occur when there is limited access to information about effective practice and policy
- However, in the academic or prevention science fields the learning is there and research is being undertaken to inform prevention practice
- The knowledge is there to inform and help others develop more effective policy and practice, Mentor communicates this knowledge to those on the ground through the Prevention Hub and endeavours to positively impact the prevention reaching the children and young people

The promotion of the need for effective drug prevention




• It will promote the need for effective drug prevention – putting this at the forefront of prevention work

It will inform all users, but specifically policy makers who are often overlooked in the need to educate about effective prevention


Desired Outcomes






- Strong part of the bid to IKEA




The European Drug Prevention Quality Standards Project (EDPQS), funded by the European Commission, is now in its second phase.

European

- It provides the first European framework for high quality drug prevention.
- The two phase Project reflects the value of partnership from working with 27 European partner organisations from 14 countries along with EMCDDA and the United Nations Office on Drugs and Crime (UNODC).
- This European Prevention Standards Partnership has ensured the work has been based on research with the focus on promoting high quality evidence based practice in prevention.
- The focus of the current phase of work is to translate the research which organised the Standards in an eight-stage project cycle, to outline the necessary steps in planning, implementing and evaluating drug prevention activities to the stage where they are accessible and used by different prevention providers.
- Toolkits will be developed for prevention commissioners as well as for practitioners to help practical implementation of the Standards to inform policy, funding and practice.
